**PLAINTIFFS' MOTION FOR APPROVAL OF ATTORNEYS' FEES, SERVICE
AWARDS, AND REIMBURSEMENT OF EXPENSES**

On October 13, 2011, the Court preliminarily approved the Settlement Agreement between Plaintiffs and Defendants Ferrellgas, Inc., Ferrellgas, L.P., and Ferrellgas Partners, L.P. *See* Doc. 254. Pursuant to that Order and Federal Rules of Civil Procedure 23(h) and 54(d), Plaintiffs hereby submit their Motion for Approval of Attorneys' Fees, Service Awards, and Reimbursement of Expenses. Settlement Class Counsel for Plaintiffs seek an award of attorneys' fees and reimbursement of expenses for a total of \$7,250,000. Defendants do not oppose this award. As is demonstrated from both the monetary and non-monetary components of the settlement, Settlement Class Counsel delivered a highly favorable result to the class. The work and effort of Settlement Class Counsel, which significantly benefitted all class members, should be fairly rewarded.

WHEREFORE, for the reasons set forth above and as more fully set forth in Plaintiffs' accompanying Memorandum in Support and exhibits thereto, Plaintiffs respectfully request that the Court grant this Motion for Approval of Attorneys' Fees, Service Awards, and Reimbursement of Expenses, and enter an Order: (1) granting approval of attorneys' fees and expenses in the amount of \$7,250,000; (2) granting approval of reasonable service awards for

individual plaintiffs to be identified for the Court prior to the February 24, 2012 Fairness Hearing; and (3) granting any other relief the Court deems just and proper.
